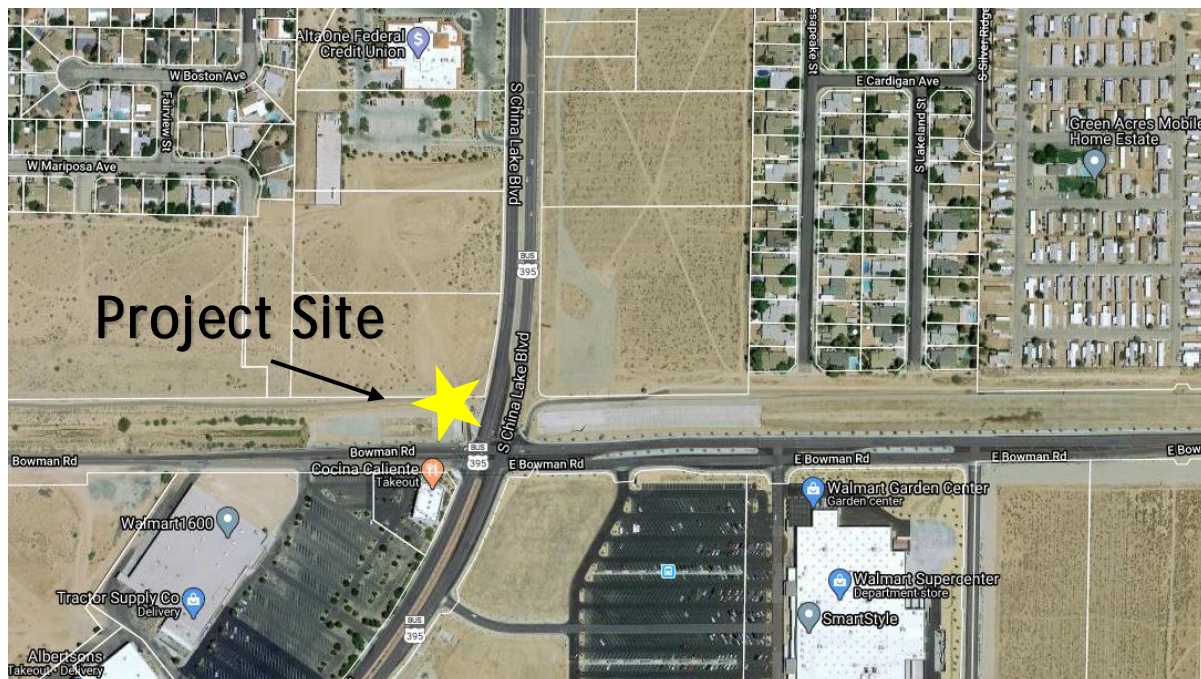

Subject: **Continued Item: Conditional Use Permit- (CUP 20-02)**- an application for a new electronic community message board located at the northwest corner of the intersection of Bowman Rd and China Lake Blvd. Applicant: Ridgecrest Chamber

BACKGROUND:

On July 26, 2005, the Planning Commission approved Conditional Use Permit PC Resolution 05-14 for the placement of a billboard in the City's right-of-way by the Ridgecrest Chamber of Commerce. The billboard approved was an electronic message board. The Chamber and the City Council had a Memorandum of Understanding for the use of the City's right-of-way. For many years the Chamber used this sign to promote community events and provide advertising opportunities for businesses. The Chamber's electronic sign has been damaged for a couple years and not operational.

The Chamber of Commerce has put together a plan for a new electronic message board sign to replace/repair the current sign.



STAFF ANALYSIS:

The Planning Commission can approve a Conditional Use Permit for a billboard if they make the following findings:

- 1) The location of the billboard is consistent with the purposes of the sign regulations of this article as set forth in the statement of purpose.
- 2) The sign may be placed along and facing the following major highways in the General and Service Commercial Districts: State Route 178 and South China Lake Blvd.
- 3) Billboards shall not exceed 20 feet in height or ten feet by 20 feet in display area per sign side.
- 4) No other billboards shall be closer than 300 feet of another billboard along the same street side.
- 5) All lighting (if provided) shall be indirect.
- 6) The sign shall be freestanding with the lowest point no less than seven feet off the ground.
- 7) The sign shall meet all other provisions of this chapter.
- 8) The findings of section 106-131 can otherwise be made.
 - a. That the proposed location of the use and the conditions under which it would be operated or maintained will not be detrimental to the public health, safety or welfare, or materially injurious to or inharmonious with properties or improvements in the vicinity.
 - b. That there are circumstances or conditions applicable to the land, structure or use which makes the granting of a use permit necessary for the preservation and enjoyment of a substantial property right.
 - c. That the proposed location of the conditional use is in accordance with the objectives of this zoning chapter and the purposes of the district in which the site is located.

Staff has determined that the project meets all of these findings:

1. The billboard is located along the major highways in the General Commercial zoned portion of South China Lake Blvd.
2. The billboard 5'5" by 11'3" which does not exceed the ten feet by 20 feet maximum.
3. No billboards are located on the same side of China Lake Blvd. within 300 feet.
4. The billboard lighting will not be direct. The billboard is electronic providing digital display advertising.
5. The sign is freestanding with the lowest point being 11'8" off the ground exceeding the required seven feet.

6. The sign will not be detrimental to the public health, safety or welfare, or materially injurious to or inharmonious with properties or improvements in the area. The Federal Highway Association and research organizations have found no link between accidents and electronic message boards.
7. The general commercial zoned land is an approved use for billboards.

Staff recommends a conditional approval with the following conditions:

1. The applicant shall comply with all applicable federal, state, county and local regulations.
2. The applicant shall enter into a new Memorandum of Understanding in writing with the City Council to allow usage of the City right-of-way.
3. The Chamber of Commerce will be responsible for the on-going maintenance and repair of the sign and base improvements.
4. Applicant will obtain a City encroachment permit for sign installation.
5. The Chamber of Commerce will provide liability insurance to go with the encroachment permit.

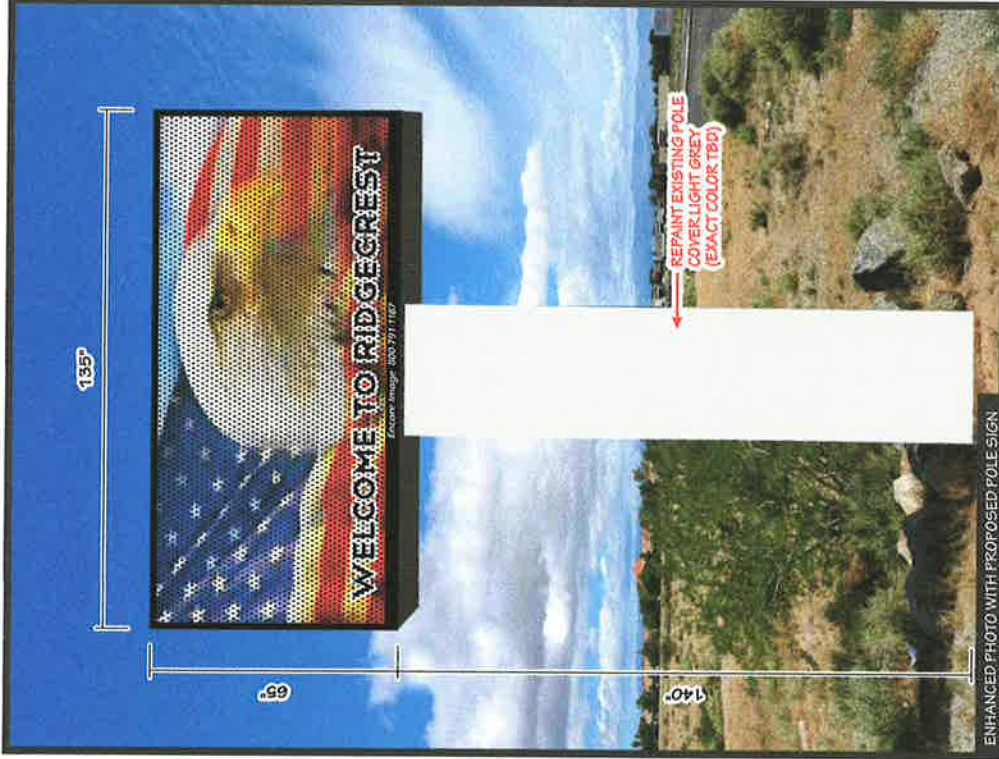
DISCUSSION:

SECTION 1. FINDINGS

On July 26, 2005, the Planning Commission held a public hearing and duly and regularly considered the application for Conditional Use Permit 05-14; A request for a billboard to be placed in the City's right of way (specifically the northwest corner of W. Bowman Road and South China Lake Blvd. Chamber of Commerce, applicant. The Planning Commission considered the evidence and approved/denied this application as set forth herein:

- (a) The location of a billboard applied for is consistent with the purposes of the sign regulations of this chapter as set forth in the Statement of Purpose.
- (b) The sign may be placed only along and facing the following major highways in the General and Service Commercial Districts: State Route 178 and South China Lake Boulevard.

- (d) No other billboard shall be closer than 300 feet of another billboard along the same side of a street.
- (e) All lighting (if provided) shall be indirect (i.e. not internally lighted.)
- (f) The sign shall be freestanding with the lowest point no less than seven feet off the ground.
- (g) The sign shall meet all other provisions of this chapter
- (h) The findings of subsection 20-21.7 can otherwise be made.

SECTION 2. DESCRIPTION

The proposal consists of Conditional Use Permit 05-14; A request for a billboard to be placed in the City's right of way (specifically the northwest corner of W. Bowman Road and South China Lake Blvd. Chamber of Commerce, applicant.
