DATE OF EVENT: February 19, 2019

TYPE OF EVENT: AB109 P.R.C.S/ Parole/ Probation Compliance Checks

LOCATION: City of Ridgecrest and Surrounding Areas in Kern County

On February 19, 2019, the Ridgecrest Police Department led by Detectives Harlow, Clinton, Mixon and Rinaldi conducted compliance checks on subjects who are on either Active Parole, Probation or Post Release Community Supervision (AB109) living within the City of Ridgecrest and surrounding areas (Buttermilk Acres and Inyokern). The primary goal of the compliance checks are to deter criminal activity in the Indian Wells Valley.

The operation was comprised of approximately 55 Law Enforcement Officers from the following agencies:

- Ridgecrest Police Department
- Delano Police Department
- Taft Police Department
- McFarland Police Department
- Kern County Probation Department
- California State Parole
- Bakersfield Police Department
- Kern County Sheriff Department

During the operation, approximately 31 searches were conducted. We had 72 planned targets with 52 non-target contacts, resulting in 25 arrests for various violations. Seized was approximately 18.9 grams of Methamphetamine, 2.7 grams of Heroin and several Meth Pipes and hypodermic needles. Also a flare gun and ammunition was seized from a subject who was prohibited. The following is a list of subjects arrested:
