

ORDINANCE NO. 136

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF RIDGECREST, CALIFORNIA, ESTABLISH-
ING CERTAIN SPEED ZONES WITHIN SAID CITY.

THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, DOES
ORDAIN AS FOLLOWS:

Section 1. A speed limit of 45 miles per hour is hereby estab-
lished in all lanes upon the following portions of the following
streets:

West Ridgecrest Boulevard from 625 feet east of Downs Street
to the westerly city limit;

South Downs Street from West Ridgecrest Boulevard to South
China Lake Boulevard.

Section 2. A speed limit of 35 miles per hour is hereby estab-
lished in all lanes upon the following portions of the following
streets:

East Bowman Road from South China Lake Boulevard east to the
easterly city limit;

West Upjohn Road from Sunset Street west to South Guam Street;

West Dolphin Avenue from South China Lake Boulevard west to
South Downs Street.

Section 3. A speed limit of 25 miles per hour is hereby estab-
lished in all lanes upon the following streets:

West Las Flores Ave. from N. Norma St. west to N. Kern St;

North Kern St. from W. Ridgecrest Blvd. to W. Las Flores Ave.;

North Inyo Street from W. Ridgecrest Blvd. to W. Las Flores Ave.;

North Mono Street from W. Ridgecrest Blvd. to W. Las Flores Ave.;

West Argus Ave. from N. Kern St. to N. Mono Street;

West Langley Ave. from S. Downs St. west to S. Guam Street;

West Midway Avenue from S. Downs St. west to S. Guam Street;

West Vulcan Ave. from S. Downs Street west to S. Mahan Street;

West Bataan Avenue from S. Downs St. west to S. Mahan Street;

West Dolphin Ave. from S. Downs St. west to S. Mahan Street;

West Franklin Ave. from S. Downs St. west to S. Mahan Street;
 West Saratoga Ave. from S. China Lake Blvd. to S. Mahan Street;
 South Mahan St. from W. Upjohn Ave. south to W. Saratoga Avenue;
 South Inyo St. from W. Upjohn Ave. south to W. Bowman Road;
 West Ridgecrest Blvd. from 625 feet east of Downs Street east to
 China Lake Blvd.


Section 4. Ordinance No. 22 of the City Council of the City of Ridgecrest is hereby amended to change the word "Sierra Street" as it appears in said ordinance to "West Las Flores Avenue".

Section 5. These speed limits shall become effective upon the posting and erection of speed limit signs as required under the Vehicle Code of the State of California.

Section 6. The City Clerk is instructed to publish this ordinance as required by law.



