

ORDINANCE NO. 142

AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF RIDGECREST AMENDING ORDINANCE NO.  
50 ADOPTING BY REFERENCE THE 1970 EDITION  
OF THE UNIFORM PLUMBING CODE

THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES ORDAIN AS  
FOLLOWS:

1. That Section 1 of Ordinance No. 50 of the City of Ridge-  
crest is hereby amended to read as follows:

"Section 1. That a certain document, three (3) copies of  
which are on file in the office of the City Clerk of the City  
of Ridgecrest, being marked and designated as the "Uniform  
Plumbing Code, 1970 Edition, published by the International  
Association of Plumbing and Mechanical Officials (formerly the  
Western Plumbing Officials Association)," including the seven  
appendices, be and the same is hereby adopted as the Plumbing  
Code of the City of Ridgecrest for the protection of the public  
health and safety, and requiring a permit for the installation  
or alteration of plumbing, gas, water, and drainage systems,  
placing responsibility for enforcement in the administrative  
authority, defining certain terms, establishing minimum regula-  
tions for the installation, alteration, or repair of plumbing,  
gas, water, and drainage systems, and the inspection thereof;  
providing penalties for its violations; and each and all of the  
regulations, provisions, penalties, conditions, and terms of such  
"Uniform Plumbing Code, 1970 Edition, published by the Interna-  
tional Association of Plumbing and Mechanical Officials," on file  
in the office of the City Clerk are hereby referred to, adopted,  
and made a part hereof as if fully set out in this Ordinance."

2. That Section 2 of Ordinance No. 50 of the City of Ridge-  
crest is hereby amended to read as follows:


"Section 2. Sections 1.1, 1.2, 1.3, subsection (10) of  
Section 1.4, Section 1.7, Section 1.10, and all of Part Two con-  
sisting of Sections 2.1 to 2.11, both inclusive, of the Uniform  
Plumbing Code, 1970 Edition, are hereby deleted."

3. Ordinance No. 78 is hereby repealed.

4. That the City Clerk shall certify to the adoption of this  
Ordinance and cause the same to be published as required by law.
