

ORDINANCE NO. 163

AN ORDINANCE OF THE CITY OF RIDGECREST AMENDING
VARIOUS SECTIONS OF ORDINANCE NO. 80 RELATING
TO SIGNS AND OUTDOOR ADVERTISING STRUCTURES

THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES ORDAIN AS FOLLOWS:

Section 1. Pursuant to Article 19 of Ordinance No. 80 of the City of Ridgecrest, certain amendments to said Ordinance have been proposed, the Planning Commission has held the hearing and made the findings and the Secretary of the Planning Commission has made the investigation, report and statement required by law, the City Council has held the hearing and finds the amendments set forth hereinafter are required in order to achieve the objectives of the ordinance prescribed in Section 102 thereof and are consistent with the purposes and application of the zoning district classification.

Section 2. Section 1002 B 6. of Ordinance No. 80 is amended to read as follows:

Section 1002 B 6. Signs, in accordance with the provisions of Section 1013 of this Article.

Section 3. Section 1002 C 6. of Ordinance No. 80 is deleted and reserved for future use.

Section 4. Section 1003 B 6. of Ordinance No. 80 is amended to read as follows:

Section 1003 B 6. Signs, in accordance with the provisions of Section 1013 of this Article.

Section 5. Section 1003 D 5. of Ordinance No. 80 is deleted and reserved for future use.

Section 6. Section 1004 B 3. of Ordinance No. 80 is amended to read as follows:

Section 1004 B 3. Signs, in accordance with the provisions of Section 1013 of this Article.

Section 7. Section 1005 B. 3. of Ordinance No. 80 is amended to read as follows:

Section 1005 B. 3. Signs, in accordance with the provisions of Section 1013 of this Article.

Section 8. Section 1013 E. of Ordinance No. 80 is amended to read as follows:

Section 1013 E. Sign projections shall be in accordance with Uniform Building Code, Volume 5, Signs, 1970 Edition. No outdoor advertising structure shall project into a public right-of-way.

Section 9. Section 1013 I. is added to Ordinance 80 to read as follows;

Ordinance No. 163


Section 1013 I. No Outdoor Advertising Structure shall be located within three hundred (300) feet to an existing Outdoor Advertising Structure.

PASSED AND ADOPTED on the 1st day of June, 1972, by the following vote:


