

ORDINANCE NO. 28

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA PURSUANT TO SECTION 35314 OF THE GOVERNMENT CODE OF CALIFORNIA.

The City Council of the City of Ridgecrest, California does ordain as follows:

SECTION 1. The City Council having previously found by Resolution that a majority protest had not been made as required by law in that certain annexation known as: Ridgecrest No. 1.

The City Council does hereby approve said annexation and declare that the same shall become a part of the City of Ridgecrest, California from and after the effective date of this Ordinance.

SECTION 2. A copy of the legal description of said annexed territory is attached hereto, and made a part hereof, marked Exhibit "A".

SECTION 3. The City Clerk is ordered to publish a copy of this Ordinance as required by law. This Ordinance shall take effect thirty (30) days after its passage.




EXHIBIT A

Beginning at the NW COR of the SE1/4 of Sec. 3 T 27S R 40E M.D.B. & M being a point on the existing corporate boundary of the City of Ridgecrest; thence East along the north line of Said SE1/4 & the existing corporate boundary to the W1/4 COR of Sec. 2 T 27S R 40E M.D.B. & M thence continuing east along the north line of the S1/2 of Said Sec. 2 & the existing corporate boundary to the E1/4 COR of Said Sec. 2 thence leaving the existing corporate boundary, south along the east line and the extension thereof of Said Sec. 2 to a point 30ft south of the SE COR of said Sec. 2 being a point on the south line of Bowman Rd. thence west along the south line of Bowman Rd. & 30ft south of the south line of Sec. 2 & Sec. 3 to a point on the SEly line of State Hwy. Rt. 212, thence Sly & Ely along said SEly line to a point on the Sly extension of the west line of SE1/4 of Said Section, said point also a point on the existing corporate boundary, thence north along said corporate boundary & the west line of SE1/4 of Sec. 3 to the P.C.B.
