

ORDINANCE NO. 75-5

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIDGECREST AMENDING ORDINANCE NO. 50 ADOPTING BY REFERENCE THE 1973 EDITION OF THE UNIFORM PLUMBING CODE, SECOND PRINTING: AND REPEALING ORDINANCE NO. 142 OF THE CITY OF RIDGECREST

THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES ORDAIN AS FOLLOWS:

Section 1. That Section 1 of Ordinance No. 50 of the City of Ridgecrest is hereby amended to read as follows:

"Section 1. That a certain document, three (3) copies of which are on file in the office of the City Clerk of the City of Ridgecrest, being marked and designated as the 'Uniform Plumbing Code, 1973 Edition, Second Printing, published by the International Association of Plumbing and Mechanical Officials (formerly the Western Plumbing Officials Association),' including appendices, said appendices to include, but not limited thereto, the 1974 Amendments to the Uniform Plumbing Code, 1973 Edition, be and the same is hereby adopted as the Plumbing Code of the City of Ridgecrest for the protection of the public health and safety, and requiring a permit for the installation or alteration of plumbing, gas, water, and drainage systems, placing responsibility for enforcement in the administrative authority, defining certain terms, establishing minimum regulations for the installation, alteration, or repair of plumbing, gas, water, and drainage systems, and the inspection thereof; providing penalties for its violations; and each and all of the regulations, provisions, penalties, conditions, and terms of such 'Uniform Plumbing Code, 1973 Edition, Second Printing, published by the International Association of Plumbing and Mechanical Officials', on file in the office of the City Clerk are hereby referred to, adopted, and made a part hereof as if fully set out in this Ordinance."

Section 2. That Section 2 of Ordinance No. 50 of the City of Ridgecrest is hereby repealed.

Section 3. That Section 7 of Ordinance No. 50 of the City of Ridgecrest is hereby amended to read as follows:

"Section 7. Any person, firm or corporation violating any of the provisions of this Ordinance or of the Code adopted herein shall be punishable by a fine of not more than Three Hundred Dollars (\$300.00), or by imprisonment for a period of not more than 90 days, or by both such fine and imprisonment. Each person, firm or corporation shall be deemed guilty of a separate offense for each day during any portion of which any violation of any provisions of this Ordinance or said code is committed, continued or permitted by such person, firm or corporation

and shall be punishable therefor as provided by this Ordinance."

Section 4. That Ordinance No. 142 is hereby repealed.

Section 5. That the City Clerk shall certify to the adoption of this Ordinance and cause the same to be published as required by law.
