

ORDINANCE NO. 93-06

**AN ORDINANCE OF THE RIDGECREST CITY COUNCIL
AMENDING ORDINANCE NO. 78-15, AND APPROVED
FEE SCHEDULE DATED JANUARY 4, 1989 TO
INCREASE BUSINESS LICENSE FEES**

THE RIDGECREST CITY COUNCIL DOES ORDAIN AS FOLLOWS:

Section 1. Amendment

Section 6-24.2 of the Ridgecrest Municipal Code is hereby amended as follows:

D-015 VENDING, ETC.	\$60	Plus \$66 for each additional employee.
E-020 WHOLESALE & ROUTE	\$60	Plus \$16 for each additional vehicle.
F-025 CATERING FROM VEHICLE	\$60	Plus \$66 for each additional vehicle.
G-030 ITINERANT/THEATERS, JUNK DEALERS	\$160	
H-035 RESIDENTIAL RENTALS	\$60	Minimum for 1-3. \$6 for every unit over 3.
I-040 MOBILEHOME SPACE RENTALS	\$60	Min. 1-3 spaces. \$6 for every unit over 3.

J-045 COMMERCIAL RENTALS	\$60	Plus \$16 for each additional parcel or structure.
K-050 POOL TABLES/BOWLING ALLEYS	\$80	Plus \$6 for each additional table or alley.
L-055 CARD ROOMS	\$390	Plus \$40 for each table <u>semi-annually</u> .
M-060 BILLBOARDS	\$60	For one sign. \$60 for each over one.
N-065 CARNIVALS/CIRCUSES (NON-CHARITABLE SPONSOR)	\$390	Per day plus \$16 for each concession.
O-070 CARNIVALS/FORTUNE TELLERS, ETC. (CHARITABLE SPONSOR)	\$100	
P-075 SHOE SHINING	\$15	Plus \$6 for each additional chair.
Q-080 NON-LICENSED CONTRACTOR	\$66	Plus \$6 for each additional employee
R-085 LICENSED CONTRACTOR	\$66	Plus \$6 for each non-licensed employee.
S-090 PART TIME/INTERMITTENT	\$9	Per day per each day of retail sales.
T-095 SWAP MEETS, ETC	\$390/day	Plus \$9 per day for each vendor not having a City license.
