

**ORDINANCE NO 95-07**

**AN ORDINANCE OF THE RIDGECREST  
CITY COUNCIL GRATING A TAXI  
FRANCHISE TO JACQUELYN SUE  
GILLESPIE, CANDY HENSON AND GUS  
GUMZ, A CALIFORNIA PARTNERSHIP,  
DOING BUSINESS AS UNITED CAB OF  
RIDGECREST**

**BE IT ORDAINED BY THE RIDGECREST CITY COUNCIL** as follows:

**Section 1. Purpose**

This Ordinance grants a taxi franchise to Jacquelyn Sue Gillespie, Candy Henson and Gus Gumz, a California partnership, doing business as United Cab of Ridgecrest (hereinafter *Franchisee*) to operate a taxi service within the City of Ridgecrest. This ordinance is authorized pursuant to Ridgecrest Municipal Code Sections 3-5.101 *et seq.* And 3-5.401 *et seq.*

**Section 2. Findings**

The City Council finds, determines and declares as follows:

- (a) The City Council has conducted a duly-noticed public hearing to determine whether a taxi franchise should be issued to franchisee pursuant to the Ridgecrest Municipal Code;
- (b) Citizens of Ridgecrest will benefit from the taxi service to be provided by the franchisee;
- (c) The transportation system of the City will be benefitted by the taxi service to be provided by the franchisee;
- (d) The taxi service to be provided by the franchisee will be for the convenience of the public and will satisfy public need for transportation services;
- (e) A franchise should be authorized on the terms and conditions set forth herein;
- (f) The granting of this franchise is exempt from environmental review under the California Environmental Quality Act.

**Section 3. Grant of Franchise**

A taxi franchise is hereby granted to Jacquelyn Sue Gillespie, Candy Henson

and Gus Gumz, a California partnership, doing business as United Cab of Ridgecrest pursuant to Ridgecrest Municipal Code Section 3-5.403 for a term of three years commencing on the effective date of this Ordinance and terminating three years thereafter.

**Section 4. Terms and Conditions**


Franchisee shall operate its taxi franchise subject at all times to the terms and conditions for franchise set forth in the Ridgecrest Municipal Code.

**Section 5. Other**

Except as provided herein, Franchisee shall comply with all provisions of the Ridgecrest Municipal Code pertaining to franchises in general and taxi franchises in particular. Proceedings to extend, suspend, or revoke this franchise shall be undertaken pursuant to the provisions of the Ridgecrest Municipal Code.
