

RESOLUTION NO. 43

RESOLUTION OF THE COUNCIL OF THE CITY OF RIDGECREST FIXING A TIME AND PLACE FOR HEARING PROTESTS BY PERSONS OWNING REAL PROPERTY WITHIN TERRITORY DESIGNATED AS RIDGECREST NO. 1 PROPOSED TO BE ANNEXED TO THE CITY OF RIDGECREST.

WHEREAS, a petition was filed with the Council of the City of Ridgecrest on the 5th day of March, 1964, requesting that certain uninhabited territory therein described be annexed to and incorporated within the City of Ridgecrest, and,

WHEREAS, said petition was signed by the owners of not less than one-fourth (1/4) of the area, of the land in such territory, and representing not less than one fourth (1/4) of the assessed value of such territory according to the last preceding equalized assessment roll of the County of Kern.

NOW, THEREFORE, in compliance with the provision of the Annexation of Uninhabited Territory Act of 1939, Chapter 297, as amended, BE IT RESOLVED by the Council of the City of Ridgecrest, as follows:

That the boundaries of the territory so proposed to be annexed to the City of Ridgecrest are described as follows:

Beginning at the NW COR of the SE1/4 of Sec. 3 T 27S R 40E M.D.B. & M being a point on the existing corporate boundary of the City of Ridgecrest; thence East along the north line of Said SE1/4 & the existing corporate boundary to the W1/4 COR of Sec. 2 T 27S R 40E M.D.B. & M thence continuing east along the north line of the S1/2 of Said Sec. 2 & the existing corporate boundary to the E1/4 COR of Said Sec. 2 thence leaving the existing corporate boundary, south along the east line and the extension thereof of Said Sec. 2 to a point 30ft south of the SE COR of said Sec. 2 being a point on the south line of Bowman Rd. thence west along the south line of Bowman Rd. & 30ft south of the south line of Sec. 2 & Sec. 3 to a point on the SEly line of State Hwy. Rt. 212,

thence Sly & Ely along said SEly line to a point on the Sly extension of the west line of SE1/4 of Said Section, said point also a point on the existing corporate boundary, thence north along said corporate boundary & the west line of SE1/4 of Sec. 3 to the P.O.B.


BE IT FURTHER RESOLVED, that Thursday, the 6th day of August, 1964, at the hour of seven thirty o'clock P.M., in Council Chambers, Las Flores School Auditorium, Ridgecrest, California, is the time when and the place where any person owning real property within such territory so proposed to be annexed and having any objections to the proposed annexation may appear before the Council of the City of Ridgecrest and show cause why such territory should not be annexed.




