

SECOND AMENDED RESOLUTION OF THE CITY COUNCIL

WHEREAS proceedings are to be taken under Improvement Act of 1911 for the proposed construction of certain street work in Assessment District No. 2; and

WHEREAS the City Council has heretofore adopted Resolution No. 249 on April 18, 1968, approving and ordering the filing of estimate, plans, specifications and map, and Amended Resolution No. 249 on June 20, 1968, approving and ordering the filing of amended estimate, plans, specifications and map for said Assessment District; and

WHEREAS certain additional changes have been made in said documents and it is desired to approve and order the filing of second amended estimate, plans, specifications and map;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST HEREWITH RESOLVES:

1. The second amended estimate of the cost and expenses for Assessment District No. 2, the second amended plans designated as "Second Amended Construction Plans for Assessment District No. 2, City of Ridgecrest", the second amended specifications designated as "Second Amended Specifications for Assessment District No. 2, Construction of Curbs, Gutters, Cross-Gutters, Sidewalks and Driveways, Ridgecrest, California", and a second amended map designated as "Second Amended Map of Assessment District No. 2" showing the boundaries of the territory to be benefited by said work and to be assessed to pay the cost and expenses of said work, are all hereby approved and ordered filed with the City Clerk.



The amount of said damages and the terms and conditions under which the same shall be payable are hereby fixed as provided in said second amended specifications.



WHEREAS, proceedings are to be taken under the Improvement Act of 1911 for the proposed construction of certain street work in Assessment District No. 2; and


