

RESOLUTION NO. 252

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, CORRECTING RESOLUTION NO. 225 CONCERNING ANNEXATION NO. 1

WHEREAS, the City Council of the City of Ridgecrest adopted Resolution No. 225 approving Annexation No. 1 on the 7th day of December, 1967; and

WHEREAS, the legal descriptions quoted in paragraph No. 1 of Resolution No. 225 were incorrect;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That Resolution No. 225 is hereby amended to read as follows:

"RESOLUTION NO. 225

"RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST APPROVING ANNEXATION NO. 1

"WHEREAS the City Council of the City of Ridgecrest has initiated proceedings to annex certain territory to the City, and notice of the hearing thereon has been given in the manner provided by law, and no protests having been made thereto at said hearing;

"NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

"1. That annexation of the following described territory to the City of Ridgecrest is herewith approved:

"The northwest quarter of the southeast quarter of Section 2, Township 27 South, Range 40 East, MDB&M, County of Kern, State of California; and

"The west 440 feet of the northeast quarter of the southeast quarter of Section 2, Township 27 South, Range 40 East, MDB&M, County of Kern, State of California, EXCEPT the south one-quarter thereof.

"2. That the City Clerk is authorized and directed to immediately prepare under seal a certified copy of this resolution, giving the date of its passage, and transmit it to the Secretary of State.

"3. That upon receipt of the certificate of filing from the Secretary of State, the City Clerk shall file the affidavit provided for by Government Code Section 34080, and shall file the statement and map or plat with the Kern County Assessor and the California State Board of Equalization as provided for by Government Code Sections 54900 et seq.


