

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF RIDGECREST, CALIFORNIA, RENAMING
RIDGECREST ROAD TO COLLEGE HEIGHTS
BOULEVARD

WHEREAS, the Planning Commission and the Post Office Department have requested that the name of the access road to the new college site be changed; and

WHEREAS, said road is a north - south road extending south from the intersection of Bowman Road and South China Lake Boulevard along the section line common to Sections 9, 10, 15 and 16, T27S, R40E, MDB&M: and

WHEREAS, said road was named "Ridgecrest Road" by Resolution No. 205 adopted July 20, 1967; and

WHEREAS, the name Ridgecrest Road is confused with Ridgecrest Boulevard; and

WHEREAS, the City of Ridgecrest has annexed said access road into the City; and

WHEREAS, the new college site is approximately five hundred feet in elevation above the intersection of Ridgecrest and China Lake Boulevards;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, RESOLVES:

1. That the North - South section line road common to sections 9, 10, 15, and 16, T27S, R40E, MDB&M, be renamed College Heights Boulevard.

2. That this change will not become effective until street name signs with the correct name have been properly posted.

RESOLUTION NO. 71-32

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF RIDGECREST RECOMMENDING A ROAD NAME CHANGE TO COLLEGE HEIGHTS DRIVE FOR THE NORTH-SOUTH SECTION LINE ROAD COMMON TO SECTION 9, 10, 15 and 16, T. 27 S., R. 40 E., M.D.B. & M., UPON ANNEXATION TO THE CITY OF RIDGECREST

WHEREAS, the Post Office Department and City Administrator have requested the name of the road leading to the new college site to be changed; and

WHEREAS, the Planning Commission has considered the request and submitted it to a committee for study; and

WHEREAS, the committee has considered the matter finding the street currently is identified as South China Lake Boulevard and Ridgcrest Road, both names similar or the same as existing roads in the City; and

WHEREAS, the committee finds only 1/2 mile of the road is within the corporate limits of the City of Ridgcrest with the majority of the road in Kern County; and

WHEREAS, the committee has recommended the name of College Heights Drive and an alternate name of College Drive for this road; and

WHEREAS, the committee has also written the Kern County Planning Department Director advising of the recommendations; and

WHEREAS, it is proposed by the committee to have the road name changed effective upon annexation of the road in conjunction with the "College Annexation"; and

WHEREAS, the Planning Commission has considered the committee report and concurs with its findings and recommendations;

NOW, THEREFORE, THE PLANNING COMMISSION OF THE CITY OF RIDGECREST RESOLVES:

That the north-south section line road common to Section 9, 10, 15 and 16, T. 27 S., R. 40 E., M.D.B.&M., be renamed College Heights Drive upon annexation of the road.
