

RESOLUTION NO. 447

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, OF PRELIMINARY DETERMINATION TO UNDERTAKE SPECIAL ASSESSMENT PROCEEDINGS FOR THE CERRO COSO ASSESSMENT DISTRICT, CITY OF RIDGECREST, KERN COUNTY, CALIFORNIA

ASSESSMENT DISTRICT NO. 4

BE IT RESOLVED by the City Council of the City of Ridgecrest, as follows:

1. There has been filed with the Clerk of the City of Ridgecrest, Kern County, California, a map entitled "Proposed Boundaries of the Cerro Coso Assessment District, City of Ridgecrest, County of Kern, State of California," which said map is incorporated herein by this reference as though fully set forth herein.

2. It is hereby determined that assessment district proceedings shall be instituted for the improvements and acquisitions to be made within the boundaries of said proposed assessment district.

3. It is hereby found, determined and ordered that FRAPWELL AND GHEZZI, ARCHITECTS A.I.A., shall be Engineer of Work in accordance with the terms and conditions of the contract to be entered into with said firm. It is further ordered that Sturgis, Den-Dulk, Douglass & Anderson, Attorneys at Law, Oakland, California, shall be Special Bond Counsel to prepare all proceedings in accordance with the terms and conditions of the contract to be entered into.

4. That the public interest and convenience will be served by the taking of special assessment proceedings for the improvements and acquisitions within the boundaries of said proposed assessment district. The cost and expenses thereof shall be borne by a

district benefited by said improvements and acquisitions. Said district shall be known and designated as Cerro Coso Assessment District, City of Ridgecrest, Kern County, California.

5. The district which shall bear the cost and expenses of said improvements and acquisitions, including all incidental expenses, and which is to be assessed to pay for the cost thereof is that district shown on a map which is on file in the office of the City Clerk of the City of Ridgecrest, which is designated, "Proposed Boundaries of the Cerro Coso Assessment District, City of Ridgecrest, County of Kern, State of California."

6. Said special assessment proceedings are to be taken under the provisions of the Municipal Improvement Act of 1913 with bonds to be issued under the provisions of Chapter 4.5, Part 5, Division 7 of the Streets and Highways Code of the State of California (Improvement Act of 1911).
