

RESOLUTION NO. 475

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, ESTABLISHING CERTAIN LIMITED OR NO PARKING ZONES ON NORTH CHINA LAKE BOULEVARD, EAST RIDGECREST BOULEVARD, BALSAM STREET, AND WEST PANAMINT AVENUE

WHEREAS, Ordinance No. 87 provides for certain curb markings to designate parking or stopping regulations pursuant to Vehicle Code Section 21458; and

WHEREAS, Section 2 of said Ordinance provides that the City Council may cause signs, curb markings or other devices to be placed so as to regulate vehicular stopping, standing, or parking;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES AS FOLLOWS:

1. The following areas are hereby established as no stopping, standing, or parking at any time zones to be designated by red curbs pursuant to Section 1a of Ordinance No. 87:

a. On the north side of West Panamint Avenue the full length of the curb between North Sanders Street and the alley east of North Sanders Street.

b. On the east side of North China Lake Boulevard from the beginning of the curb return at East Ridgecrest Boulevard

- (1) north 531 feet,
- (2) south and east around the curb return 179.87 feet to end curb return, and
- (3) east along the north side of East Ridgecrest Boulevard 734 feet from the end of the above specified curb return.

2. The following areas are hereby established pursuant to Section 1d of Ordinance No. 87 as limited parking or standing zones to be designated by green curbs and markings to indicate that parking in said area shall not exceed fifteen (15) minutes:

a. On the west side of Balsam Street from 18 feet south of the end of the south curb return on Balsam Street at West Panamint Avenue to 26 feet south of the end of the curb return.

b. On the south side of West Panamint Avenue from the beginning of the curb return at Balsam Street to 20 feet west of the beginning of the curb return.


3. The above established zones shall be subject to the other restrictions provided for in Ordinance No. 87.





