

RESOLUTION NO. 491

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, OF AWARD OF CONTRACTS, ASSESSMENT DISTRICT NO. 4, CERRO COSO COLLEGE, CITY OF RIDGECREST, KERN COUNTY, CALIFORNIA

WHEREAS, by Resolution adopted on the 1st day of February, 1973, it was directed that bids be called for the improvement work to be done in Assessment District No. 4, Cerro Coso College, City of Ridgecrest, Kern County, California, and that the time fixed for receiving sealed bids or proposals was the 1st day of March, 1973, at the hour of 4:00 o'clock P.M. of said day; and

WHEREAS, Notice Inviting Sealed Bids was duly published in the time and manner required by law; and

WHEREAS, all bids having been publicly opened, examined and declared pertaining to the doing of the work and improvements described in the Resolution of Intention, which Resolution of Intention is hereby expressly referred to for a description of said improvements, and for all other particulars relative to the proceedings under said Resolution of Intention; and

WHEREAS, the City Council of the City of Ridgecrest, Kern County, California, on the 15th day of March, 1973, ordered the improvements and acquisitions to be made in said assessment district;

NOW, THEREFORE, IT IS HEREBY RESOLVED that the City Council of the City of Ridgecrest, Kern County, California, hereby rejects all of said proposals or bids, except that herein mentioned, and hereby awards the contracts for said improvements to the lowest responsible bidders, to wit: ASPHALT CONSTRUCTION CO., INC., for the road construction work; PACIFIC ENGINEERS for the underground electri-

cal work; and W.M. LYLES CO. for the sewer construction work, at the prices named in the bid of each of said bidders on file in the office of the City Clerk of the City of Ridgecrest, and


IT IS HEREBY DIRECTED that the City Clerk of the City of Ridgecrest publish a Notice of Award of Contract.



NOTICE OF AWARD OF CONTRACTS
