

RESOLUTION NO. 502

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIDGECREST, CALIFORNIA, APPROVING AND ADOPTING
THE BUDGET FOR THE FISCAL YEAR 1973-74

WHEREAS, the City Council of the City of Ridgecrest, California, has considered the proposed budget for the fiscal year 1973-74; and

WHEREAS, a public hearing was held on said proposed budget and all persons desiring to be heard thereon were given the opportunity to make comments and recommendations and objections; and

WHEREAS, various changes and amendments in said proposed budget have been made, and the City Council desires to adopt in final form the proposed budget as changed and amended;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That the proposed budget for the fiscal year 1973-74 in the amount of \$2,802,119, as changed, a copy of which is attached hereto as Exhibit "A", and incorporated herein and made a part hereof, is herewith approved and adopted.
2. That the City Council hereby authorizes transfer from the Transient Occupancy Tax Fund to the General Fund of \$31,848 for expenditure for community promotion and recreation purposes in 1973-74.
3. That the City Council hereby authorizes transfer of \$183,159 from the State Gas Tax Fund to the General Fund for expenditure for the construction and maintenance of City streets in 1973-74.
4. That the City Council hereby authorizes transfer of \$55,328 from the Local Transportation Fund to the General Fund for expenditure for construction of improvements on City streets.
5. That the City Council authorizes transfer of \$26,000 from the Traffic Safety Fund to the General Fund for expenditure for Police Department salary and other costs.
6. That the City Council hereby authorizes transfer of \$12,000 from the Regional Park Development Fund for expenditure for Police Department salary and other costs.
7. That the City Council authorizes transfer of \$46,308 from the Federal Revenue Sharing Fund to the General Fund for expenditure from purchase of City Hall at 139 Balsam Street and for a portion of the Police Department salaries and other costs.

8. That at least three (3) copies of said 1973-74 budget in its final and approved form, as adopted herein, shall be filed with the City Clerk and shall be open to public inspection at all reasonable times.
