A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
RIDGECREST, CALIFORNIA, ACCEPTING AN OFFER OF  
DEDICATION OF A PORTION OF DOWNS STREET RIGHT-  
OF-WAY IN TRACT NO. 1578

WHEREAS, all that portion of land reserved for future street  
purposes shown on Tract No. 1578 as recorded in Book 7 of Maps on  
Pages 113, 114, 115, 116, 117, in the office of the County Recorder,  
County of Kern, State of California; and

WHEREAS, at the time of said approval certain street rights-of-  
way offered for dedication thereon were not accepted; and

WHEREAS, such offers of dedication have never been terminated  
and abandoned in the manner provided by law; and

WHEREAS, it is desired to rescind the previous action of non-  
acceptance or rejection, and to accept certain street rights-of-way  
set forth hereinafter pursuant to California Business and Professions  
Code Section 11616;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST  
RESOLVES AS FOLLOWS:

1. That the rejection of the offers of dedication of those  
certain street rights-of-way described hereinafter is herewith re-  
scinded and said offers are accepted.
2. That upon construction of all necessary improvements such  
street rights-of-way shall be opened for public use.
3. That those street rights-of-way which are the subject of  
this resolution and which are referred herein are described as follows:

The East 12 feet of Lots 23, 24, 25, 26, 27, 28, 29, 30,  
31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44,  
45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58,  
59, 60, 61, and 62 of said Tract 1578

4. That this resolution of acceptance shall be forthwith re-  
corded in the Kern County Recorder's Office.
