RESOLUTION NO. 74-13

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIDGECREST, CALIFORNIA, ACCEPTING AN OFFER OF
DEDICATION OF A PORTION OF SARATOGA AVENUE AND
DOWNS STREET RIGHT-OF-WAY IN TRACT 1466

WHEREAS, all that portion of land reserved for future street
purposes as shown on Tract No. 1466 as recorded in Book 6 of Maps
on pages 163-167 in the office of the County Recorder of the County
of Kern; and

WHEREAS, at the time of said approval certain street rights-of-
way offered for dedication thereon were not accepted; and

WHEREAS, such offers of dedication have never been terminated
and abandoned in the manner provided by law; and

WHEREAS, it is desired to rescind the previous action of non-
acceptance or rejection, and to accept certain street rights-of-way
set forth hereinafter pursuant to California Business and Professions
Code Section 11616;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES
AS FOLLOWS:

1. That the rejection of the offers of dedication of those certain
street rights-of-way described hereinafter is herewith rescinded and
said offers are accepted.

2. That upon construction of all necessary improvements such
street rights-of-way shall be opened for public use.

3. That those street rights-of-way which are the subject of this
resolution and which are referred herein are described as follows:

The South 15 feet of Lots 386, 341, 340, 295, 294, 249, 248, 203,
202, 157, 156, 112, 111, 61, 62, 63, 64, and 69 of said Tract 1466
and
The East 15 feet of lots 1, 18, 19, 35, 36, 37, 50, 65, 66, 67,
68, and 69 of said Tract 1466.

4. That this resolution of acceptance shall be forthwith re-
corded in the Kern County Recorder's Office.
