RESOLUTION OF THE CITY COUNCIL ABANDONING
PROCEEDINGS FOR THE CONSTRUCTION OF CERTAIN
IMPROVEMENTS IN ASSESSMENT DISTRICT PURSUANT
TO THE "IMPROVEMENT ACT OF 1911"

ASSESSMENT DISTRICT NO. 8

WHEREAS, this City Council did by the adoption of its
Resolution of Intention No. 74-10, declare its intention to order
the construction of certain works and improvements to be done and
made pursuant to the terms and provisions of the "Improvement Act
of 1911," being Division 7 of the Streets and Highways Code of the
State of California in an assessment district known and designated as

and;

WHEREAS, at the time set for the public hearing on protests
and objections to the proposed improvement, the extent of the district
to be assessed or to the grades to which said improvement was to be
done, this City Council did proceed to hear the same; and

WHEREAS, at the time set for public hearing the Engineer did
present and make a recommendation as to the construction bids
previously received relating to the works of improvement within said
assessment district; and

WHEREAS, at this time this City Council is not desirous to
proceed with the project or the improvements and is desirous to
abandon the proceedings,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE
CITY OF

SECTION 1. The above recitals are all true and correct.

SECTION 2. All bids received for the works of improvement
within the previously mentioned assessment district are hereby
rejected.

SECTION 3. Proceedings had and taken under and pursuant to the
"Improvement Act of 1911," being Division 7 of the Streets and Highways
Code of the State of California, for the work and improvement
proposed by Resolution of Intention No. 74-10 adopted on the 7th
day of February, 1974 and as by proposed Resolution of Intention No.
74-67, all in a special assessment district known as
ASSESSMENT DISTRICT NO. 8

SECTION 4. Notwithstanding the above, Resolution No. 74-59
adopted on the 1st day of August, 1974, establishing the prevailing
rate of wages to be paid for public works construction, shall remain
in full force and effect.
