RESOLUTION OF THE CITY COUNCIL AWARDING THE
CONTRACT FOR THE CONSTRUCTION OF CERTAIN
PUBLIC WORKS OF IMPROVEMENT IN A SPECIAL
ASSESSMENT DISTRICT.

ASSESSMENT DISTRICT NO: 10

WHEREAS, this City did on the 15th day of MARCH, 1977,
publicly open, examine and declare all sealed proposals or bids
for doing the work and improvement described in Resolution No. 77-11,
which Resolution and "Report" subsequently approved by said City
Council are hereby expressly referred to for a description of said
work and improvement and for all particulars relative to the proceed-
ings for works of improvement in a special assessment district known
and designated as

ASSESSMENT DISTRICT NO. 10

(hereinafter referred to as the "Assessment District").

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL
OF THE CITY OF

RIDGECREST

AS FOLLOWS:

SECTION 1. That the above recital is true and correct.

SECTION 2. That the City Council of the aforestated City,
State of California, hereby rejects all of said proposals or bids
except that herein mentioned and does hereby award the construction
contract for doing said work and making improvements in the Assess-
ment District to the lowest responsible bidder, to wit:

WAL-CON CONSTRUCTION, INC. and
JOHN M. ARTUKOVICH CO. J.V.

at the prices named in the bid of said bidder on file in the Office
of the City Clerk of said City. The contractor shall execute the
contract within fifteen (15) days after he has been notified in
writing to so execute the contract and commence construction.

SECTION 3. That this award of contract is hereby condi-
tioned upon and made subject to the receipt of monies from the
sale of bonds.

SECTION 4. That the works of improvement shall be con-
structed in the manner and form as set forth in the plans and spe-
cifications for these proceedings, and all as previously approved
by this City Council as a part of the "Report", all as required
by law and specifically the "Municipal Improvement Act of 1913",
being Division 12 of the Streets and Highways Code of the State
of California.




