RESOLUTION OF THE CITY COUNCIL APPROVING REPORT UNDER THE "SPECIAL ASSESSMENT INVESTIGATION, LIMITATION AND MAJORITY PROTEST ACT OF 1931", AND FIXING A DATE OF HEARING THEREON

ASSESSMENT DISTRICT NO. 11

WHEREAS, this Council did, on the 21st day of SEPTEMBER, 1977, by Resolution No. 77-49, order the preparation of a Report under the provisions of the "Special Assessment Investigation, Limitation and Majority Protest Act of 1931", being Division 4 of the Streets and Highways Code of the State of California, in the matter of the construction of certain public works of improvement in a special assessment district known and designated as

ASSESSMENT DISTRICT NO. 11

(hereinafter referred to as the "Assessment District"); said public works of improvement are generally described as follows:

The construction of certain curbs, gutters, sidewalks, driveway approaches, cross gutters, water services and all appurtenances and appurtenant work in connection therewith in a special assessment district in the City of Ridgecrest known and designated as ASSESSMENT DISTRICT NO. 11.

WHEREAS, such Report has been prepared and submitted to this City Council.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE

CITY OF RIDGECREST

CALIFORNIA, AS FOLLOWS:

SECTION 1. That the above recitals are all true and correct.


SECTION 2. That the Report for the Assessment District so prepared and presented be, and the same hereby is, approved and the fact and date of this approval shall be endorsed thereon and the Report shall be filed with the City Clerk.

SECTION 3. THAT THIS CITY COUNCIL DOES HEREBY FIX THE 3rd DAY OF NOVEMBER, 1977, AT THE HOUR OF 6:30 O'CLOCK P.M. IN THE COUNCIL CHAMBERS IN THE CITY HALL AS THE TIME AND PLACE WHEN A HEARING ON SAID "REPORT" WILL BE HELD BY THIS CITY COUNCIL. THE CITY CLERK SHALL GIVE NOTICE OF SUCH HEARING BY MAILING A COPY OF THE NOTICE, POSTAGE PREPAID, TO ALL PERSONS OWNING REAL PROPERTY WHICH IS PROPOSED TO BE ASSESSED TO PAY ANY PART OF THE COST OF THE WORK, WHOSE NAMES AND ADDRESSES APPEAR ON THE LAST EQUALIZED ASSESSMENT ROLL AVAILABLE ON THE DATE THE REPORT WAS COMMENCED, AT HIS ADDRESS AS SHOWN ON SUCH ROLL, OR AS KNOWN TO THE CITY CLERK, ALL IN THE MANNER AND FORM PROVIDED FOR IN SAID DIVISION 4.
