A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF RIDGECREST APPROVING AND ORDERING  
THE VACATION OF A PORTION OF SOUTH VALLEY  
STREET

WHEREAS, The City Council of the City of Ridgecrest heretofore passed a resolution declaring its intention to vacate a portion of South Valley Street described hereinafter; and

WHEREAS, notice of the time and place for hearing all persons interested in or objecting to said proposed vacation was given in the manner provided by law; and

WHEREAS, said hearing having been held on March 21, 1979, at which time all persons interested in or objecting to said proposed vacation were heard, and no oral or written objections having been made by any persons;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That it is found and determined that the portion of South Valley Street described hereinafter is unnecessary for present or prospective public street purposes.
2. That the following described portion of South Valley Street is herewith ordered abandoned and vacated:

All that portion of the northwest  $\frac{1}{4}$  of the northwest  $\frac{1}{4}$  of Section 2, T. 27 S., R. 40 E., M.D.M., in the City of Ridgecrest, State of California, as shown on Tract No. 1619 as recorded in Book 7 of maps, page 200 in the Office of the County Recorder of the County of Kern, described as follows:

A strip of land being parallel to and measured at right angles, 10.00 feet from the following Lots 188 thru 204, 251 thru 265 on the west side of Valley Street and Lots 295, 333 thru 346, 348, 388 thru 403 on the east side of Valley Street.


