

RESOLUTION NO. 79-4

A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF RIDGECREST DECLARING INTENTION  
TO ORDER VACATION OF A PORTION OF VALLEY  
STREET RIGHT-OF-WAY IN TRACT 1619

WHEREAS, it appears that the portion of Valley Street between California State Highway Route 178 (Ridgecrest Boulevard) and Church Avenue, more particularly described below, is unnecessary for present or prospective public use; and

WHEREAS, it is desired to hold a public hearing to hear and consider the proposed abandonment and vacation of the said portion of Valley Street, pursuant to the procedures set forth in Section 8320, Et. Seq. of the streets and highway code of the state of California.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That it intends to abandon and vacate that portion of Valley Street between California State Highway Route 178 (Ridgecrest Boulevard) and Church Avenue, which is more particularly described as follows:

All that portion of the northwest  $\frac{1}{4}$  of the northwest  $\frac{1}{4}$  of Section 2, T.27S., R.40E., M.D.M., in the City of Ridgecrest, State of California, as shown on Tract No. 1619 as recorded in Book 7 of maps, page 200 in the Office of the County Recorder of the County of Kern, described as follows:

A strip of land being parallel to and measured at right angles, 10.00 feet from the following Lots 188 thru 204, 251 thru 265 on the west side of Valley Street and Lots 295, 333 thru 346, 348, 388 thru 403 on the east side of Valley Street.

2. That portion of Valley Street proposed to be abandoned and vacated is shown on a map or plan on file in the office of the City Clerk, reference to which is hereby made for further particulars.
3. That a hearing on said proposed abandonment and vacation will be held at 7:00 p.m. February 21, 1979, in the City Council Chambers, City Hall, 130 Balsam Street, Ridgecrest, California, at which time all persons interested in or objecting to said proposed abandonment and vacation may appear and be heard.

4. That this resolution shall be published in the manner prescribed by law and copies thereof shall be posted conspicuously along the portion of Valley Street to be abandoned and vacated at least ten (10) days before the date of said hearing, such copies to be posted not more than three hundred (300) feet apart and at least three (3) copies thereof shall be posted.


