

RESOLUTION NO. 79-49

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST APPROVING AND ORDERING THE VACATION OF 6 FEET OF AN EXISTING 6 FOOT BY 20 FOOT PUBLIC UTILITY EASEMENT, LOCATED IN THE 20 FOOT FRONT YARD SET BACK AREA OF TRACT 3725.

WHEREAS, The City Council of the City of Ridgecrest heretofore passed a resolution declaring its intention to vacate portions of a public utility easement; and

WHEREAS, notice of the time and place for hearing all persons interested in or objecting to said proposed vacation was given in the manner provided by law; and

WHEREAS, said hearing having been held on December 5, 1979, at which time all persons interested in or objecting to said proposed vacation were heard, and no oral or written objections having been made by any persons;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That it is found and determined that the portion of the public utility easements described hereinafter is unnecessary for present or prospective public utility purposes.

2. That the following described portion of public utility easements are herewith ordered abandoned and vacated:

Being a portion of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 33, T. 26S., R. 40E., M.D.M., in the City of Ridgecrest, County of Kern, State of California, as shown on Tract No. 3725 as Recorded in Book 26 of Maps, Page 67 and 68 in the office of the County Recorder of the County of Kern, described as follows:

The east 6 feet of the west 20 feet of the north 6 feet of Lots 1, 21, and the east 6 feet of the west 20 feet of the south 6 feet of Lots 2 through 8, 22 through 26, and the west 6 feet of the east 20 feet of the north 6 feet of Lots 20, 32, and the west 6 feet of the east 20 feet of the south 6 feet of Lots 13 through 19, 27 through 31, and the north 6 feet of the south 20 feet of the east 6 feet of Lots 9, 11 and the north 6 feet of south 20 feet of the west 6 feet of Lots 10, 12. Shown as 6'x20' P.U.E. on said Tract No. 3725.


3. That a certified copy of this resolution be recorded by the City Clerk in the office of the Kern County Recorder.
