

RESOLUTION NO. 79-9

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST DECLARING INTENTION TO ORDER VACATION OF A PORTION OF GATEWAY BOULEVARD RIGHT-OF-WAY IN TRACT 1619, AND RESCINDING RESOLUTION NO. 79-5

WHEREAS, it appears that the portion of Gateway Boulevard between Church Avenue and Upjohn Avenue, more particularly described below, is unnecessary for present or prospective public use; and

WHEREAS, it is desired to hold a public hearing to hear and consider the proposed abandonment and vacation of the said portion of Gateway Boulevard, pursuant to the procedures set forth in Sections 8320, Et. Seq. of the Streets and Highway Code of the State of California.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That it intends to abandon and vacate that portion of Gateway Boulevard between Church Avenue and Upjohn Avenue which is more particularly described as follows:

All that portion of land reserved for future street purposes in the southwest $\frac{1}{4}$ of the northwest $\frac{1}{4}$ of Section 2, T.27S., R.40 E., M.D.M., in the City of Ridgecrest, State of California, as shown on Tract No. 1619 as recorded in Book 7 of maps, page 200 in the County Recorder of the County of Kern, described as follows:

The west 10.00 feet of Lots 150, 151, 152, 153, 154, 155, 156, 157, 158, 159, 160, 161, 162, 163, 164, 165, 166, 167, 168, 169, 170, 171, 172.

2. That portion of Gateway Boulevard proposed to be abandoned and vacated is shown on a map or plan on file in the Office of the City Clerk, reference to which is hereby made for further particulars.
3. That a hearing on said proposed abandonment and vacation will be held at 7:00 P.M. on March 21, 1979, in the City Council Chambers, City Hall, 139 Balsam Street, Ridgecrest, California, at which time all persons interested in or objecting to said proposed abandonment and vacation may appear and be heard.
4. That this resolution shall be published in the manner prescribed by law and copies thereof shall be posted conspicuously along the portion of Gateway Boulevard to be abandoned and vacated at least ten (10) days before the date of said hearing, such copies to be posted not more than three hundred (300) feet apart and at least three (3) copies thereof shall be posted.

5. That City Council Resolution No. 79-5 is hereby rescinded.




