

RESOLUTION NO. 80-25

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA AUTHORIZING THE EXTENSION OF CONTRACT WITH CALIFORNIA DEPARTMENT OF AGING FOR TITLE III, PART C-1, FUNDS, FORMERLY TITLE VII, AND USDA CASH-IN-LIEU OF COMMODITIES FUNDS FOR THE RIDGECREST NUTRITION PROGRAM.

WHEREAS, the California Department of Aging, by letter dated 22 February, 1980, notified the City of Ridgecrest that contract for the Ridgecrest Nutrition Program was to be amended; and

WHEREAS, in order to carry out the purposes of Title 45 Code of Federal Regulations, Public Welfare, Chapter XIII Administration on Aging, Part 1324 pursuant to provisions of Title VII (Nutrition Program for the Elderly) of the Older Americans Act of 1965, as amended, the California Department of Aging has been authorized to receive funds for paying part of the costs for providing older Americans, particularly those with low incomes, with low cost, nutritionally sound meals served in strategically located centers where they can obtain other social and rehabilitative services; and

WHEREAS, in addition, Section 707 of the Older Americans Act, as amended, requires the Secretary of Agriculture to maintain, a level of not less than 25 cents per meal in donated food to recipients of grants and contracts under Title VII of the Act which authorizes the Nutrition Program for the Elderly; That amount is subject to adjustment on an annual basis to reflect changes in the services for food away from home of the Consumer Price Index published by the Bureau of Labor Statistics of the Department of Labor. The reimbursement rate for FY 80 is 43¢ per meal served; and

WHEREAS, in order to carry out the purposes of Section 707 of the Older Americans Act of 1965, as amended by Public Law 95-65, the California Department of Aging has been authorized to receive funds from the Department of Agriculture for paying part of the costs of purchasing food commodities for Title III, Part C, Nutrition Program for the Elderly.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Ridgecrest that:

1. It accepts the terms and provisions of the California Department of Aging's Contract No. 15792271 in conjunction with Ridgecrest Nutrition Program No. 70678101 in an amount not to exceed \$154,803, consisting of \$133,559 for congregate Nutrition Service and One-Time-Only funds and \$21,244 for USDA federal funds.

2. The term of this agreement is from April 1, 1979 to September 30, 1980.
