

RESOLUTION NO. 80-8

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, DECLARING INTENTION TO ORDER THE VACATION OF A 10 FOOT PUBLIC UTILITIES EASEMENT LOCATED IN THE EAST 5 FEET OF LOTS 64, THROUGH 84 AND IN THE WEST 5 FEET OF LOTS 43 THROUGH 63 OF TRACT 1619.

WHEREAS, it appears that the 10 foot public utilities easement located in the east 5 feet of Lots 64 through 84 and in the west 5 feet of Lots 43 through 63 of Tract 1619 is unnecessary for present or prospective public use; and

WHEREAS, it is desired to hold a public hearing thereon pursuant to the procedures set forth in the Public Service Easements Vacation Law (Calif. Gov't. Code Secs. 50430 ff.);

NOW, THEREFORE, IT IS HEREWITH RESOLVED, DETERMINED AND ORDERED AS FOLLOWS:

1. The City Council declares its intention to vacate part of the public utilities easement described hereinafter.

2. The part of said easement proposed to be vacated is shown on the map or plan on file in the office of the City Clerk, and is described as follows:

A 10 foot public utilities easement located in the east 5 feet of Lots 64 through 84, and in the west 5 feet of Lots 43 through 63 of Tract 1619.

3. A hearing on this matter is set for 7:00 p.m., on March 5, 1980 in the City Council Chambers, City Hall, 139 Balsam Street, Ridgecrest, California, at which time all persons interested in or objecting to said proposed public utility easement vacation, may appear and be heard.

4. This resolution, or notice thereof, shall be published and posted in the manner required by law.


