

RESOLUTION NO. 81- 10

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, ADOPTING AN EMPLOYEES' DEFERRED COMPENSATION PLAN AND AUTHORIZING THE EXECUTION OF AGREEMENTS RELATING TO SAID PLAN, AS DESIGNATED BY FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION

WHEREAS, the City of Ridgecrest has in its employ employees who are and will be rendering valuable services to the City; and

WHEREAS, said employees may desire to defer income until retirement for the purpose of deferring Federal and State Income Taxes on said income; and

WHEREAS, the City of Ridgecrest has considered the establishment of a Deferred Compensation Plan for said employees, in accordance with Federal and State law and regulations, and believes that the adoption of said Plan will enhance the efficiency and morale of the employees and will be in the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Ridgecrest, California, that the City of Ridgecrest, California hereby establishes and adopts for its employees a Deferred Compensation Plan as designated by First Federal Savings and Loan Association, attached hereto as Exhibit "A", to be effective immediately and to remain in effect until terminated by further resolution.

BE IT FURTHER RESOLVED that the City Administrator is hereby appointed to administer the Plan on behalf of the City and is authorized to execute Participation Agreements with eligible officers, officials, and employees, and all other Documents and Agreements necessary to implement and administer the Plan, except that, Agreements with institutions acting as Plan Administrator and depository shall be subject to approval by the City Council.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, ACCEPTING AN OFFER OF DEDICATION OF A PORTION OF ROUTE 178 (INYO KERN ROAD) RIGHT-OF-WAY IN PARCEL MAP NO. 4139

WHEREAS, all that portion of land reserved for future street purposes shown on Parcel Map No. 4139 as recorded in Book 19 of Parcel Maps at Page 3, in the office of the County Recorder, County of Kern, State of California; and

WHEREAS, at the time of said approval certain street rights-of-way offered for dedication thereon were not accepted; and

WHEREAS, such offers of dedication have never been terminated and abandoned in the manner provided by law; and

WHEREAS, it is desired to rescind the previous action of non-acceptance or rejection, and to accept certain street rights-of-way set forth hereinafter pursuant to California Business and Professions Code Section 11616;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES AS FOLLOWS:

1. That the rejection of the offers of dedication of those certain street rights-of-way described hereinafter is herewith rescinded and said offers are accepted.

2. That upon construction of all necessary improvements such street rights-of-way shall be opened for public use.

3. That those street rights-of-way which are the subject of this resolution and which are referred herein are described as follows:

The South 25 feet of the North 55 feet of the Northwest ¼ of Northeast ¼ of Section 29, T. 26 S., R. 40 E., M.D.M.

4. That this resolution of acceptance shall be forthwith recorded in the Kern County Recorder's Office.


