A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIDGECREST ORDERING THE VACATION OF PART OF A
PUBLIC UTILITY EASEMENT IN TRACT 1382, LOT 19

WHEREAS, notice of said proposed action was published and posted in the manner required by law, and a hearing was held for the purpose of hearing evidence by all interester persons; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST HEREWITH RESOLVES, ORDERS AND DETERMINES:

1. That from all the evidence submitted, the following portions of the public utility easement described hereinafter are unnecessary for present or prospective public use, and they are hereby ordered vacated:

The south ten feet of property of Lot 19, Tract No. 1382, except that the westerly five feet be retained as an easement, located at the corner of South Norma Street and West Church Avenue.

That all obstructions and utilities, if required, be removed or relocated at the expense of the property owner.

2. That a certified copy of this resolution shall immediately hereafter be recorded by the City Clerk in the Kern County Recorder's Office.



2. That a certified copy of this resolution shall immediately hereafter be recorded by the City Clerk in the Kern County Recorder's Office.




