

RESOLUTION NO. 81- 6

A RESOLUTION OF THE CITY OF RIDGECREST, CALIFORNIA, APPROVING AND ORDERING THE VACATION OF A PUBLIC UTILITY EASEMENT, LOCATED IN THE WEST FIVE (5) FEET OF LOTS 81 AND 90, AND THE EAST FIVE (5) FEET OF LOTS 80 AND 91, EXCEPTING THE NORTHERLY FIVE (5) FEET OF LOTS 91 AND 90, AND THE SOUTHERLY FIVE (5) FEET OF LOTS 80 AND 81 OF TRACT MAP 2193 - CITY OF RIDGECREST, APPLICANT

WHEREAS, the City Council of the City of Ridgecrest, California, heretofore passed a resolution declaring its intention to vacate a portion of a public utility easement described hereinafter; and

WHEREAS, notice of the time and place for hearing all persons interested in or objecting to said proposed vacation was given in the manner provided by law; and

WHEREAS, said hearing having been held on February 18, 1981, at which time all persons interested in or objecting to said proposed vacation were heard, and no oral or written objections having been made by any persons;

NOW, THEREFORE, the City Council of the City of Ridgecrest resolves as follows:

1. That it is found and determined that the portion of public utilities easement described hereinafter is unnecessary for present or prospective public use.
2. That the following described portion of public utilities easement is herewith ordered abandoned and vacated:

The west five (5) feet of Lots 81 and 90, and the east five (5) feet of Lots 80 and 91, excepting the northerly five (5) feet of Lots 91 and 90, and the southerly five (5) feet of Lots 80 and 81 of Tract Map 2193.

3. That a certified copy of this resolution be recorded by the City Clerk in the Office of the Kern County Recorder.


