

RESOLUTION NO. 82-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY
OF RIDGECREST DESIGNATING LOCATIONS OF LOADING
ZONES

WHEREAS, Ordinance No. 82-6, adopted by the City Council of the City of Ridgecrest on March 17, 1982 repealed Section 8-5 of the Municipal Code of the City of Ridgecrest, which set forth designated locations of commercial loading zones, and

WHEREAS, said Ordinance No. 82-6 further established Sections 8-1.3 and 8-1.4 of the Municipal Code of the City of Ridgecrest which provide that the Council shall, by resolution, determine the location and size of loading zones for materials and passengers.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES HEREBY RESOLVE:

Pursuant to Sections 8-1.3 and 8-1.4 of the Municipal Code of the City of Ridgecrest, loading zones are hereby established at the following locations for the purposes designated:

1. Commercial loading zones on certain alleys.

Vehicles parking or standing shall be prohibited for any purpose, other than commercial trucks loading or unloading, on the following portions of the following public alleys:

- a. The full width of the full length of the north-south alley to the rear of Lots 33, 34, and 35 of Tract 1722 in the block between West Station Avenue, West Panamint Avenue, Balsam Street, and the extension of North Sanders Street.
- b. The east one-half of the full length of the north-south alley to the rear of Lots 29 through 32 of Tract 1722 in the block between West Panamint Avenue, West French Avenue, Balsam Street, and North Sanders Street.
- c. The west one-half of the full length of the north-south alley to the rear of Lots one through six of Tract 1595 in the block between West French Avenue, West Argus Avenue, Balsam Street, and North Sanders Street.
- d. The full width of the full length of the east-west alley along the south line of Lot 12 in Tract 1722 in the block between West Ridgecrest Boulevard, West French Avenue, Balsam Street, and North China Lake Boulevard.

e. The full width of the full length of the north-south alley to the rear of Lots 6 through 11 of Tract 1722 in the block between West Ridgecrest Boulevard, West French Avenue, Balsam Street, and North China Lake Boulevard.

f. The full width of the south 273 feet of the north-south alley to the rear of Lots 2 through 5 of Tract 1722 in the block between West French Avenue, West Argus Avenue, Balsam Street, and North China Lake Boulevard.

g. The west one-half of the north 132 feet of the north-south alley in the block between West French Avenue, West Argus Avenue, Balsam Street, and North China Lake Boulevard.

h. The full width of the full length of the north-south alley to the rear of Lots 12 through 23 of Tract 1404 in the block between West Argus Avenue, West Coso Avenue, Balsam Street, and North China Lake Boulevard.

i. The west one-half of the south 380 feet of the north-south alley to the rear of Lots 34 through 40 of Tract 1404 in the block between West Coso Avenue, West Las Flores Avenue, Balsam Street, and North China Lake Boulevard.

j. The full width of the north 220 feet of the north-south alley to the rear of Lots 1, 2, 3, and 4 of Tract 1404 in the block between West Coso Avenue, West Las Flores Avenue, Balsam Street, and North China Lake Boulevard.

It is the intention of the City Council that this Comprehensive Resolution be effective concurrently with the effective date of Ordinance No. 82-6 and shall be in effect until further amendment by the City Council.
