A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, APPROVING THE HOUSING ELEMENT OF THE GENERAL PLAN OF THE CITY OF RIDGECREST.

WHEREAS, the City Council of the City of Ridgecrest has considered and reviewed the Housing Element of the Ridgecrest General Plan 1981-1995, including all supporting maps, diagrams, charts, and descriptive material referred to therein and made a part thereof; and

WHEREAS, during the formulation and consideration of said element, there has been services provided by a private consultant firm, a Citizens Advisory Committee, the City's planning staff and consultation with appropriate public officials and state and local agencies, civic educational, professional, and other organizations, and citizens of the community in an effort to obtain the best information to maximize the element's effectiveness for the best use of the housing goals within the City; and

WHEREAS, the Planning Commission has held a public hearing on the Housing Element on April 12, 1982, notice of which was given in the manner required by law; and

WHEREAS, the City Council of the City of Ridgecrest held a public hearing on May 19, 1982, notice of which was given in the manner required by law:

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES HEREBY RESOLVE:

That this Council adopts the Negative Declaration, and approves the Housing Element of the General Plan 1981-1995 for the City of Ridgecrest.

WHEREAS, Orbit Industries, Inc., dba China Lake Investments, LTD, Developer, entered into a Security Agreement for Tract 4244, Units J, P, Q, T, B, I, dated December 20, 1979, calling for certain improvements including, in part, street and sewer main improvements on Gold Canyon Drive, more particularly identified as "Gold Canyon Reconstruction" and "Gold Canyon Realignment" within Exhibit "A" of said Agreement; and

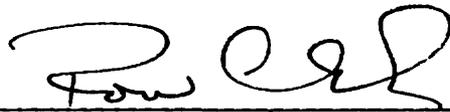
