A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF RIDGECREST, CALIFORNIA, APPROVING
THE AGREEMENT WITH THE COUNTY OF KERN TO
PROVIDE FOR THE COLLECTION OF SPECIAL
ASSESSMENT

WHEREAS, the City of Ridgecrest desires that the County of Kern continue to collect the City's special assessments; and

WHEREAS, California Statutes, including Sections 29304, 51300 et seq, 51330 et seq, and 51800 of the Government Code, provide a means by which County may add to each special assessment, an amount fixed by agreement between a city and county as compensation for such service; and

WHEREAS, County of Kern has done a cost study of said service and set its cost currently at \$.15 per parcel and will periodically review the cost of said services in the future;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST hereby resolves that:

The contract proposed by the County of Kern being previously approved and the Mayor authorized to sign, that a copy of this Resolution be forwarded to the County Auditor-Controller's Office.



AGREEMENT
TO
PROVIDE FOR THE COLLECTION
OF SPECIAL ASSESSMENTS

THIS AGREEMENT, made and entered into this 21st day of July, 1982, by and between the County of Kern, a political subdivision of the State of California, hereinafter referred to as "COUNTY and the City of Ridgecrest, a municipal corporation, hereinafter referred to as "CITY",

W I T N E S S E T H :

WHEREAS:

(a) CITY has heretofore transferred assessment and tax collection functions to COUNTY pursuant to Article I of Chapter 2 of Part 2 of Division 1 of Title 5 of the Government Code of the State of California (commencing with §51500); and

(b) CITY is desirous of contracting with COUNTY pursuant to §51300 et seq. or §51330 et seq. of the Government Code for the purpose of transferring its function of special assessment collection to COUNTY; and

(c) COUNTY is capable and willing to collect for CITY all special assessments levied by CITY, and will collect them at the same time and in the same manner as other taxes on the tax roll are collected; and

(d) Sections 29304 and 51800 of the Government Code provide for compensation to be paid to COUNTY for collecting special assessments for CITY and further provide that the amount of said compensation shall be fixed by agreement and added to the amount of the special assessments to be collected by COUNTY.

NOW, THEREFORE, It Is Mutually Agreed:

1. COUNTY shall collect special assessments levied by CITY. All routine refunds or cancellations of invalid or erroneous assessments shall be made or handled on behalf of CITY by the respective departments of COUNTY.

2. The following charge shall be added to each special assessment, and when a special assessment is collected in installments, said added charge shall be likewise collected in equal parts by COUNTY's Tax Collector for distribution to the general fund of COUNTY:

For special assessments levied upon any land or real property by any city, county, district or other public corporation, officer or body: a charge not to exceed \$1.00 for each parcel bearing such an assessment.

3. Payments to CITY's Treasurer by COUNTY's Auditor-Controller will be made at the same times and in the same manner as CITY's ad valorem taxes are paid.

4. This Agreement may be terminated for the ensuing fiscal year by giving ten (10) days notice in writing to the other party prior to June 1 of the proceeding fiscal year.

5. Notice given to the parties under this Agreement shall be deemed given when delivered to the following officials and places:
