A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, DESIGNATING THE SITE LOCATED ON CITY OWNED PROPERTY NORTH OF THE GOLF CENTER PARKING LOT AS THE LOCATION FOR A NEW ANIMAL SHELTER

WHEREAS, the City of Ridgecrest is in need of a new animal shelter; and

WHEREAS, the Ridgecrest City Council has appointed a Citizen Committee to recommend an appropriate site for locating a new animal shelter facility; and

WHEREAS, the Citizen Committee has recommended strongly that a preferred location for a new animal control facility would be to utilize City owned property north of the City Golf Center parking lot.

NOW, THEREFORE, BE IT RESOLVED by the Ridgecrest City Council that it designates City owned property north of the Golf Center parking lot as the location for a new animal shelter facility.


