A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST SUMMARILY VACATING CERTAIN FUTURE ALLEY LINES AND THE SOUTH TEN FEET OF CERTAIN PUBLIC UTILITIES EASEMENTS.

WHEREAS, the following described easements have been superseded by relocation to other easements; and

WHEREAS, there are adequate existing public utility easements to service the existing parcels of land in the area, and the following described future alley lines and easements are not needed for public utilities; and

WHEREAS, the vacation of said future alley lines and easements does not cut off access to any parcel; and

WHEREAS, the vacation of the said future alley lines and easements shall not terminate any public service easement that has been used within the past five years;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES HEREBY RESOLVE:

1. That pursuant to Chapter 4 of Division 9 of the Streets and Highways Code, that certain future alley lines and easements described in Exhibit "A" attached and made a part hereof are hereby vacated.
2. That the City Clerk shall cause this Resolution to be recorded in the Office of the County Recorder of Kern County.
3. From and after the date of adoption of this Resolution, said vacated portions of the future alley lines and easements no longer constitute a Street, Highway, or Public Service Easement.
