1. Reference is hereby made to the map or plat showing the general nature, location and extend of said acquisitions and improvements for a further description of said work and for all particulars relating thereto, which map or plat is on file in the office of the City Clerk and open to public inspection.
2. The costs thereof will be assessed upon a district benefited thereby the exterior boundaries of which are as shown on a map entitled "Proposed Boundaries of Church Avenue Improvement Project between Downs Street and Sunset Street", prepared by the Public Works Department of the City of Ridgecrest, on file in the office of the City Clerk.
3. That said proceedings for said acquisitions and improvements shall be conducted pursuant to Division 4 of the Streets and Highways Code, the Special Assessment Investigation, Limitation and Majority Protest Act of 1931, and the Municipal Improvement Act of 1913, and bonds shall be issued pursuant to the Improvement Bond Act of 1915.


