

RESOLUTION NO. 83-93

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIDGECREST, CALIFORNIA, RELATIVE TO WORKERS'
COMPENSATION BENEFITS FOR REGISTERED VOLUNTEER
"DISASTER SERVICE WORKERS"

WHEREAS, Section 8580 of the Government Code (Chapter 1454, Statutes 1970) provides:

"The Emergency Council shall establish by rule and regulation various classes of disaster service workers and the scope of the duties of each class. The Emergency Council shall also adopt rules and regulations prescribing the manner in which disaster service workers of each class are to be registered. All such rules and regulations shall be designed to facilitate the paying of workers' compensation."; and

WHEREAS, the California Emergency Council has adopted rules and regulations establishing classes of disaster service workers, the scope of duties of each class, and the manner of registration of such volunteer disaster service workers; and

WHEREAS, Section 8612 of the Government Code (Chapter 1454, Statutes 1970) provides:

"Any disaster council which both agrees to follow the rules and regulations established by the California Emergency Council pursuant to the provisions of Section 8580 and substantially complies with such rules and regulations shall be certified by the Emergency Council. Upon such certification, and not before, the disaster council becomes an accredited disaster council."; and

WHEREAS, the City of Ridgecrest has registered and will hereafter register volunteer disaster service workers; and

WHEREAS, the City of Ridgecrest desires to become an "accredited disaster council" organization in order that injured disaster service workers registered with it may benefit by the provisions of Chapter 10 of Division 4 of Part 1 of the Labor Code;

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
ALBANY, CALIFORNIA, RELATIVE TO WORKERS'
COMMITTEE RIGHTS FOR REGISTERED VOLUNTEER
DISASTER SERVICE WORKERS

WHEREAS, Section 2081 of the Government Code (Chapter 145, Statutes 1975)

"The Emergency Council shall establish by rule and regulation
various classes of disaster service workers and the scope of
the duties of each class. The Emergency Council shall also
adopt rules and regulations prescribing the manner in which
disaster service workers of each class are to be registered.
All such rules and regulations shall be designed to carry
into the paying of workers' compensation;" and

WHEREAS, the California Emergency Council has adopted rules and regula-
tions establishing classes of disaster service workers, the scope of duties of
each class, and the manner of registration of such volunteer disaster service
workers and

WHEREAS, Section 2015 of the Government Code (Chapter 145, Statutes 1975)

"Any disaster council which both agrees to follow the rules
and regulations established by the California Emergency
Council pursuant to the provisions of Section 2081 and
substantially complies with such rules and regulations shall
be certified by the Emergency Council. Upon such cer-
tification, and not before, the disaster council shall have an
accredited disaster council;" and

WHEREAS, the City of Albany has registered and will remain a regis-
tered disaster service workers; and

WHEREAS, the City of Albany desires to become an "accredited disaster
council" organization in order that injured disaster service workers
participate with it in benefits provided by the provisions of Chapter 145, Division 4
of Part 1 of the Labor Code;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST hereby agrees to follow the rules and regulations established by the California Emergency Council pursuant to the provisions of Section 8580 of the Government Code.

The City Clerk is hereby instructed to send a certified copy hereof to the California Emergency Council.




