

RESOLUTION NO. 84-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST, CALIFORNIA, ESTABLISHING VOTING PRECINCTS AND POLLING PLACES, APPOINTING PRECINCT BOARD MEMBERS AND FIXING COMPENSATION FOR THE GENERAL MUNICIPAL AND SPECIAL MUNICIPAL ELECTION OF SAID CITY ON TUESDAY, APRIL 10, 1984, HERETOFORE CALLED BY RESOLUTION NO. 83-101 OF THE CITY COUNCIL.

WHEREAS, a General Municipal and Special Municipal Election, to be held on Tuesday, April 10, 1984, has been heretofore called by Resolution No. 83-101, adopted on December 20, 1983.

NOW, THEREFORE, the City Council of the City of Ridgecrest, California, does hereby resolve, declare, determine and order as follows:

SECTION 1. That for the purpose of holding said General Municipal and Special Municipal Election, there shall be and are hereby established ten (10) voting precincts consisting (of consolidations) of the regular election precincts in the City of Ridgecrest established for the holding of state and county elections, as said regular election precincts exist on the date of adoption of this resolution. That the polling places for the respective precincts shall be the places hereinafter designated; and that the persons hereinafter named, being competent and qualified electors and residents of said City are hereby appointed precinct board members of their respective voting precincts and they shall hold said election and make return thereof in the manner provided by law.

SECTION 2. That the compensation of the persons hereinbefore named as precinct board members is hereby fixed at the sum of \$50.00 for each Inspector and \$45.00 for each Judge and Clerk, plus an additional \$5.00 for attendance of training session, for said election. The rental for each of such polling places, where a charge is made, shall be the sum not to exceed \$35.00 for said election.

SECTION 3. That the City Clerk shall certify to the passage and adoption of this Resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute of passage and adoption thereof in the records of the proceedings of the City Council of said City, in the minutes of the meeting at which time the same is passed and adopted.
