

RESOLUTION NO. 84-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST APPROVING GENERAL PLAN AMENDMENT 83-03, SEGMENT II, A REQUEST TO CHANGE THE GENERAL PLAN LAND USE MAP FROM CIVIC/INSTITUTIONAL TO COMMERCIAL/PROFESSIONAL OFFICE ON APPROXIMATELY 2.79 ACRES GENERALLY LOCATED AT THE SOUTHEAST CORNER OF RICHMOND ROAD AND UPJOHN AVENUE; CITY OF RIDGECREST, APPLICANT.

WHEREAS, the City of Ridgecrest has requested a General Plan Amendment; and

WHEREAS, on January 3, 1984 the City Council held a public hearing thereon, notice of time and place having been given as provided by law; and the Planning Commission held a public hearing on December 12, 1983, notice of time and place having been given as provided by law; and

WHEREAS, the staff recommended the application be approved; and

WHEREAS, this Council has considered all the plans, comments, testimony and evidence offered at the time of public hearing and approves the Negative Declaration, having found that the project will not have a substantial adverse effect on the environment, and having found General Plan Amendment, Segment II to be in the best interest of the public:




