RESOLUTION NO. 84-28

A RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF RIDGECREST, CALIFORNIA, SUMMARILY VACATING  
CERTAIN FUTURE STREET LINES

WHEREAS, certain future Street Lines described in Exhibit "A", attached hereto and made a part hereof, have not been accepted on behalf of the Public; and

WHEREAS, there are adequate existing rights-of-way to service existing parcels of land within the area; and

WHEREAS, the vacation of said future Street Lines do not cut off access to any parcel; and

WHEREAS, sufficient Public Utility Easements within said future Street Lines shall be retained and therefore vacation of said future Street Lines would not terminate any Public Service Easement that has been used within the past five years;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES HEREBY RESOLVE:

1. That pursuant to Chapter 4 of Division 9 of the Streets and Highways Code, that certain future Street Lines described in Exhibit "A" attached hereto and made a part hereof, are hereby vacated, excepting therefrom the Public Utility Easements as provided in said Exhibit "A".
2. That the City Clerk shall cause this Resolution to be recorded in the Office of the County Recorder of Kern County.
3. From and after the date of adoption of this Resolution, said vacated portions of the future Street Lines no longer constitute a Street Highway, or Public Service Easement.

RESOLVED FURTHER, that BANK is authorized to act upon this resolution until written notice of its revocation is delivered to BANK, and that the authority hereby granted shall apply with equal force and effect to the successors in office of the officers named herein.

# BANK CARD AGREEMENT — BUSINESSES

The undersigned, doing business as a  sole proprietorship  partnership  ~~corporation~~ <sup>City</sup>

 principal place of business at 139 Balsam Street, Ridgecrest, CA 93555

\_\_\_\_\_ will, from time to time, request that you issue  BankAmericard Visa or  
 Master Charge cards using the above name, which bank cards are intended for business use by our employees.

I/We hereby agree:

1. To all of the terms and conditions of the Bank of America NT&SA  BankAmericard Visa or  
 Master Charge Account Agreement(s), which presently reads as follows (substituting, as appropriate, the neuter gender for any personal pronouns contained therein):

I promise to: • Pay you according to the terms of your Truth-in-Lending Disclosure Statement for:  
 1. Credit obtained by me or by any other person I permit to use my account, even if that person exceeds my permission, and 2. All finance and other charges, including reasonable attorney's fees if you sue me to collect. • Let you know immediately if my credit card is lost or stolen. • Return to you all credit cards issued by Bank of America on my account, if asked to do so. • Stay within the credit limit you assign to me, unless I get your approval to borrow beyond this limit.

I agree that if I or any other person who agrees to these terms break any of the above promises, or do not pay any other debt as agreed, whether owed to you or to anyone else: • You may refuse to extend credit to me or to anyone else using my account. • You may require me to immediately pay the entire balance owing on my account, even if the balance is not then due. • You may cancel my account.

I also agree that you may change the terms of this agreement or the terms of your Truth-in-Lending Statement at any time. Such changes will apply to the balance in my account on the date you make them effective.

If more than one person has agreed to these terms, we will be "jointly and severally" liable. This means that you may collect from or sue any of us without giving up any of your rights against the others.

This agreement is effective on June 14, 1976 and replaces any previous Bank Card Agreement.

I understand that from time to time you may receive information concerning me from others. You also may furnish information on my account to others seeking such information.

2. Notwithstanding the provisions of any printed notice hereafter received by us purporting to relate to our liability to the Bank for unauthorized use of a Bank Card, we agree that if ten or more Bank Cards are issued to us we agree to assume responsibility for repayment of all charges incurred through the use of such Bank Cards, whether or not such use was authorized by us, our employees or other persons authorized by our employees.
