

RESOLUTION NO. 87-13

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST OVERRULING PROTESTS AND OBJECTIONS AND ORDERING WORK TO BE DONE FOR SIDEWALK AND CURB COMPLETION PROJECT NO. SW-87-1.

The City Council of the City of Ridgecrest finds, determines, declares and resolves as follows:

1. Findings

Under the Streets and Highways Code, the Superintendent of Streets of the City of Ridgecrest notified the owners of real property located on the streets set forth in Exhibit "A" attached hereto, to construct or cause to be constructed certain improvements also described on Exhibit "A" in front of the property. The Council conducted a duly noticed public hearing to pass upon the objections or protests raised by any property owner or other interested persons.

2. Protests

Protests or objections have been duly filed by 1 property owners or other interested persons, which protests are hereby overruled.

3. Further Review


The Superintendent of Streets be, and he hereby is, directed to determine if construction of the improvements in front of the real property set forth in Exhibit "A" in the City of Ridgecrest has been commenced and prosecuted to completion with due diligence as required by the notice hereinabove mentioned and, if not, said Superintendent of Streets be, and he hereby is, authorized and directed to commence construction of sidewalks and curbs in front of the real property located on the streets set forth in Exhibit "A" and attached hereto;

4. Construction

Construction shall be commenced by the Superintendent of Streets sixty (60) days from and after the notice is given to the property owner. Upon the completion of the construction, the Superintendent of Streets shall cause notice of the cost of the construction to be given in the same manner as the Notice to Construct was given and the notice shall specify the day, hour and place when the City Council will thereon pass upon a report by the Superintendent of Streets of the cost of construction, together with objections or protests if any, which may be raised by any property owner liable to be assessed for the cost of such construction, and any other interested persons.
