**AGREEMENT FOR SUPPLEMENTAL  
POLICE SERVICES**

As of October 1, 1988, the City of Ridgecrest, hereinafter "City" and the Ridgecrest Housing Corporation, hereinafter "Corporation" agree as follows:

**Section 1. Purpose**

Corporation desires to obtain supplemental police protection for housing units within the City of Ridgecrest owned by the Corporation and known as Cimarron Gardens. City is willing to provide such services upon the terms and conditions stated herein.

**Section 2. Term**

The term of this Agreement shall commence on date first written and terminating on June 30, 1989, provided this agreement shall be extended from year-to-year thereafter, upon the terms and conditions herein stated.

**Section 3. Consideration**

(a) Corporation shall pay City the sum of \$7,780 per month for the supplemental police services described herein. The monthly payment shall be remitted to the City on or before the 15th day of month next following the month during which the services were provided.

(b) On or about July 1st of each year, the parties shall determine the cost of supplemental services. If the parties agree upon revisions to the amount of consideration, this agreement shall be extended for another year. Such agreement shall be memorialized by the parties. If the parties fail to agree, this agreement shall terminate.

**Section 4. Description of Supplemental Services**

The supplemental services which the City shall provide consist of the police services described on Exhibit 1 attached hereto and hereby incorporated by this reference.


**Section 5. Reports**

City Administrator shall prepare quarterly reports showing the amount of time expended under this agreement and arrest activities. These reports shall be provided to the Corporation in a manner which does not impair the ability of the police department to discharge its duties.




