

RESOLUTION NO. 88-34

RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF RIDGECREST APPROVING RESOLUTION OF  
INTENTION AND MAP OF BOUNDARIES OF PROPOSED  
ASSESSMENT DISTRICT NO. 87-1, INDIAN WELLS  
VALLEY WATER DISTRICT, COUNTY OF KERN, STATE  
OF CALIFORNIA

WHEREAS, the Board of Directors of Indian Wells Valley Water District has submitted to the City Council of the City of Ridgecrest (the "City Council") a certified copy of Resolution No. 87-54 of said Board of Directors requesting the approval of the Board of Supervisors pursuant to Section 10104 of Streets and Highways Code of the formation of a proposed assessment district designated "Assessment District No. 87-1, Indian Wells Valley Water District, County of Kern, State of California," pursuant to the provisions of the Municipal Improvement Act of 1913, Division 12 (commencing with §10000) of the Streets and Highways Code, for the construction and installation of certain water system facilities within and for said assessment district; and

WHEREAS, said Board of Directors has also submitted to the City Council for approval, pursuant to said Section 10104, a proposed resolution of intention with respect to the formation of said assessment district and the ordering of the construction and installation of said water system facilities entitled:

"RESOLUTION OF THE BOARD OF DIRECTORS OF INDIAN WELLS VALLEY WATER DISTRICT DECLARING INTENTION TO ORDER THE ACQUISITION AND CONSTRUCTION OF CERTAIN IMPROVEMENTS WITHIN AND FOR A PROPOSED ASSESSMENT DISTRICT AND THE PAYMENT OF CERTAIN EXPENSES INCIDENTAL THERETO PURSUANT TO THE MUNICIPAL IMPROVEMENT ACT OF 1913, DESCRIBING THE ASSESSMENT DISTRICT TO BE ASSESSED TO PAY THE COSTS AND EXPENSES OF SUCH IMPROVEMENTS, AND DETERMINING THAT BONDS SHALL BE ISSUED IN THE AMOUNT OF THE UNPAID ASSESSMENT PURSUANT TO THE IMPROVEMENT BOND ACT OF 1915,"

to be adopted by said Board of Directors pursuant to Section 10200 of the Streets and Highways Code, and a map of the proposed boundaries of said proposed assessment district entitled "Proposed Boundaries of Assessment District No. 87-1 of Indian Wells Valley Water District, County of Kern, State of California," which resolution and map are on file with the City Clerk of the City of Ridgecrest; and

WHEREAS, the City Council, upon reviewing Resolution No. 87-54 of the Board of Directors of Indian Wells Valley Water District and said proposed resolution of intention and boundary map, has determined that it is in the best interests of the residents and owners of property within said proposed

assessment district that the City Council approve the formation of said assessment district, said proposed resolution of intention and said proposed boundary map;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF RIDGECREST AS FOLLOWS:

Section 1. The formation of an assessment district designated "Assessment District No. 87-1, Indian Wells Valley Water District, County of Kern, State of California" by the Board of Directors of Indian Wells Valley Water District is hereby approved. The aforementioned proposed resolution of intention with respect to the formation of said assessment district and the ordering of the construction and installation of certain water system facilities, and the aforementioned map of the proposed boundaries of said assessment district are also hereby approved. The approval of the formation of said assessment district and of the said proposed resolution of intention and map of the proposed boundaries thereof is given pursuant to Section 10104 of the Streets and Highways Code for the purpose of authorizing the Board of Directors of Indian Wells Valley Water District to adopt said resolution of intention initiating the proceedings for the formation of said assessment district and the ordering of the construction and installation of said water system facilities and taking each and every step required or suitable for the consummation of the construction and installation of such facilities and the levying, collecting and enforcement of the assessments to cover the expenses thereof, and the issuance and enforcement of bonds to represent unpaid assessments.

Section 2. The City Clerk of the City of Ridgecrest shall transmit a certified copy of this resolution to the Board of Directors of Indian Wells Valley Water District.
