

RESOLUTION NO. 88-44

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY ON APRIL 12, 1988, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW.

WHEREAS, a General Municipal Election was held and conducted in the City of Ridgecrest on Tuesday, April 12, 1988, as required by law; and

WHEREAS, notice of the election was duly and regularly given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that, in all respects, the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in cities; and

WHEREAS, pursuant to Resolution No. 88-01 adopted January 6, 1988, the City Clerk of the City canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. The total number of ballots cast in the City except absentee ballots was 2116. The total number of absentee ballots cast in the City was 220, making a total of 2336 ballots cast in the City.

Section 2. The names of persons voted for at the election for Member of the City Council of the City are as follows:

David J. Allen

Michael R. Mower

Florence S. Condos

Michael J. Thomas

Patrick L. Lilly

Thomas R. Wiknich

Section 3. That the number of votes given at each precinct and the number of votes given in the city to each of such persons above named for the respective offices for which the persons were candidates are as listed in Exhibit "A" attached.

Section 4. The City Council does declare and determine that:

Michael R. Mower was elected as Member of the City Council of the City for the full term of four years;

Florence S. Condos was elected as Member of the City Council of the City for the full term of four years;

Patrick J. Lilly was elected as Member of the City Council of the City for the full term of four years;

Section 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election showing;

1. The total number of ballots cast in the City;
2. The names of the persons voted for;
3. For what office each person was voted for;
4. The number of votes given at each precinct to each person;
5. The number of votes given in the city to each person.

Section 6. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk shall also administer to each person elected, the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 7. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.


