

RESOLUTION NO. 90-24

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST APPROVING REPORT OF SUPERINTENDENT OF STREETS OF COST OF CONSTRUCTION AND CONFIRMING ASSESSMENT FOR SIDEWALK AND CURB COMPLETION PROJECT NO. SW-89-2, WEST CHURCH AVENUE BETWEEN SOUTH CHINA LAKE BOULEVARD AND SOUTH NORMA STREET.

The City Council of the City of Ridgecrest finds, determines, declares and resolves as follows:

1. Report of Street Superintendent Approved

The Superintendent of Streets of this City has heretofore filed a report with the City Clerk of the cost of construction of the above mentioned project. The Council has examined said report and has found that said report contains each and every item required by the Streets and Highways Code Section 5881. The report of the Superintendent of Streets be, and is hereby approved.

2. Assessments Confirmed

The assessment levied against those parcels of real property for the cost of construction of said sidewalks and/or curbs be, and they are hereby, confirmed.

3. Installment Payments

That a period of five (5) days will be allowed property owners to pay all or any portion of their assessment in cash. Said five (5) day period shall commence on the day after this Council confirms the amount of the assessment. Any portion of the assessment remaining unpaid shall be placed by the County Tax Collector on the tax roll and collected as part of the real property tax bill for a period of one year together with interest at the rate of zero percent (0%) per annum on the declining balance.


