

RESOLUTION NO. 90-45

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST DECLARING ITS INTENT TO CONSTRUCT IMPROVEMENTS; SETTING A PUBLIC HEARING THEREON AND PROVIDING NOTICE FOR SIDEWALK AND CURB COMPLETION PROJECT NO. SW-90-1, THE WEST SIDE OF SOUTH RICHMOND ROAD BETWEEN EAST RIDGECREST BOULEVARD AND EAST CHURCH AVENUE.

The City Council of the City of Ridgecrest resolves as follows:

1. Purpose and Scope

The Superintendent of Streets of the City of Ridgecrest has recommended certain public improvements to be installed pursuant to Streets and Highways Code Sections 5870 et seq. This resolution implements the Superintendent's recommendation.

2. Subject Properties

The Superintendent of Streets shall initiate proceedings under the Streets and Highways Code Sections 5870 et seq. for the purpose of constructing certain public improvements in front of the properties (hereinafter "subject properties") described on Exhibit A attached hereto.

3. Subject Improvements

The improvements described on Exhibit A attached hereto (hereinafter "subject improvements") be and they are hereby ordered in front of the subject properties.

4. Public Hearing

On April 18, 1990, at the hour of 7:00 p.m., or as soon thereafter as the matter may be heard, in the Council Chambers, City Hall, 100 West California Avenue, Ridgecrest, California, the City Council shall conduct a public hearing on the question of whether the subject improvements shall be installed.

5. Notice

The Superintendent of Streets shall notify the owner or person in possession of the subject properties by posting a "Notice to Construct" in a conspicuous place on each property and by mailing a postcard, postage prepaid, to the person in possession of such property, or to the owner thereof at his last known address as the same appears on the last equalized assessment

rolls or to the name and address of the person owning such property as shown in the records of the Office of the Clerk. The notice shall also specify the day, hour and place when the City Council will hear and pass upon objections or protests, if any, which may be raised by any property owner or other interested persons.
