A RESOLUTION OF THE CITY COUNCIL OF
RIDGECREST, CALIFORNIA SUMMARILY VACATING A
20' PEDESTRIAN EASEMENT BETWEEN LOTS 282, 281,
265 AND 266 OF TRACT 1552.
