

RESOLUTION NO. 90-75

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST ADOPTING A REVISED COMPENSATION PLAN FOR MANAGEMENT, MID-MANAGEMENT, CONFIDENTIAL, AND OTHER EMPLOYEE POSITIONS IN THE CITY OF RIDGECREST.

THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES as follows:

Section 1. Salaries

(a) The following employees are hereby recognized as the City's top management group. As such, the employees are expected to accept and exercise a higher degree of responsibility than other employees and shall be compensated as follows:

(b) Sections 1 and 24 of Resolution No. 89-74 are hereby repealed.


