

RESOLUTION 93-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST DECLARING INTENTION TO ORDER VACATION OF ALL PORTIONS OF THE PUBLIC ACCESS ALLEY TO THE REAR OF LOTS 50 THROUGH AND INCLUDING LOT 61 OF TRACT 1466, SUBJECT TO RESERVATION OF A PUBLIC UTILITY EASEMENT; DAGMY, POLLOCK, LUNING, RENKE-EDWARDS, DEWEY AND TROZZI/ APPLICANTS.

WHEREAS, it appears that the public access alley to the rear of lots 50 through and including lot 61 of Tract 1466 located between Downs Street and Springer Avenue is unnecessary for present and or prospective public use: and

WHEREAS, it appears, however, that the public convenience and necessity requires the reservation of certain easements in the area proposed for abandonment and vacation; and

WHEREAS, it is desired to hold a Public Hearing thereon, pursuant to the procedures set forth in Sections 8320, et seq of the Streets and Highways Code of the State of California;

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That it intends to abandon and vacate for public access purposes, the public access alley to the rear of lots 50 through and including lot 61 of Tract 1466 located between Downs Street and Springer Avenue.

Said public access alley of Tract 1466 proposed to be abandoned and vacated is shown on a plan on file in the office of the City Clerk of the City of Ridgecrest, reference to which is made for further particulars.

2. That the proposed abandonment and vacation of said described public access alley of Tract 1466 for public access purposes would be subject to and the City does reserve and except from such vacation for public utility purpose the use of all that portion of the public access alley located in the City of Ridgecrest, County of Kern State of California more particularly described as follows:

The public access alley located to the rear of lots 50 through and including lots 61 of Tract 1466 between Downs Street and Springer Avenue.

3. That a hearing on said proposed abandonment and vacation will be held at 7:00 P.M. on Wednesday, May 19, 1993 in the Council Chambers, City Hall, 100 W. California Avenue, Ridgecrest, California, at which time all persons interested in or objecting to said proposed abandonment and vacation may appear and be heard.
4. That this resolution shall be published and posted in the manner prescribed by law.


